2. Bidding will be conducted in accordance to **National Competitive Bidding (NCB)** procedures specified in the Malawi Public Procurement Act, 2017.
3. Interested eligible bidders may obtain further information and inspect the Bidding Documents from ESCOM's Procurement Division at the address given in paragraph 8(a) below from **08:00 to 12:00 hrs, 13:00 to 16:00 hrs** local time (**Monday to Friday**) except national public holidays.
4. A complete set of Bidding Documents in English language may be purchased by interested bidders at 7(b) below upon payment of a non-refundable fee

of **MK5, 000.00**. The method of payment will be cash or bank certified cheque. The document may be collected by the bidder or their chosen representative.

5. Bids must be delivered to the Tender Box at address at 7(c) below on or before **Thursday, 08th April 2021 at 10:00 hours' local time**. Electronic bidding will not be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address 7(d) below on **Thursday, 08th April 2021 at 10:00 hours' local time**.
6. Bids must be accompanied by a Bid Security as specified in the Bidding Documents or a Bid Securing Declaration Form if the Bidder is 100% owned by Malawian Nationals. The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
